



Jim Lott is the Executive Vice President of the Hospital Association of Southern California, where he is responsible for health care policy development, advocacy, and association communications for hospitals serving Los Angeles, Orange, San Bernardino, Riverside, Santa Barbara, and Ventura Counties. He also serves on the L.A. Care Board of Governors, the Claremont University Consortium Board of Overseers, and the board of the Los Angeles Economic Development Corporation.

Prior to his move to Los Angeles, he served a five-year stint as the President and Chief Executive Officer of the Hospital Council of San Diego and Imperial Counties, a trade association representing the hospitals and health systems in the southern-most region of California. Prior to San Diego, Jim served for nine years as Staff Director and Chief Consultant to the Senate Committee on Health and Human Services of the California Legislature. He also held various administrative, policy development and advocacy positions with the Los Angeles County Health Department over a six-year period.

Jim received his undergraduate education at Cal State L.A., his MBA degree from the University of Redlands, and he is completing his dissertation for a doctorate in education with a concentration in organizational leadership at Pepperdine University.
